YANDICOOGINA SOUTH HIGH GRADE BEDROCK SAMPLES

- **New outcropping bedrock iron mineralisation identified at Yandicoogina South**
- **Eleven rock chip samples collected and assayed, indicating the presence of high grade, low phosphorous hematite mineralisation**
- **High Grade Samples including 66.0% Fe, 1.8% SiO₂, 1.2% Al₂O₃, 0.05% P**
- **Further reconnaissance planned to identify additional bedrock and CID mineralisation**

Emerging Pilbara iron ore developer, **Hemisphere Resources Limited (ASX: HEM)** is pleased to announce recent fieldwork has identified the presence of high grade, low phosphorous hematite mineralisation adjacent to the identified Channel Iron Deposit (CID) at the Company's Yandicoogina South project.

Hemisphere's Yandicoogina South project is strategically located immediately south of Rio's Yandicoogina mine.

Managing Director, Danny Costick said fieldwork following on from the successful delineation of the Yandicoogina CID Resource has identified bedrock hematite and additional CID targets on the Yandicoogina South tenement (E47/1904), with the CID mineralisation continuing onto tenement ELA47/2474, currently under application.

"These results are highly encouraging and warrant more comprehensive fieldwork and target generation over the Weeli Wolli Banded Iron Formation at Yandicoogina South during April 2011," Mr Costick said.

"We've had a series of good results from Yandicoogina South. In February we reported a maiden resource and earlier this month, metallurgical testwork, confirmed Direct Shipping Ore product quality within the Yandicoogina South CID."

"This combination of positive results has encouraged us to advance consideration of commercialisation options at the Project."

Further drilling is planned at Yandicoogina South during the latter half of 2011 to evaluate all bedrock and CID targets identified during the planned fieldwork.

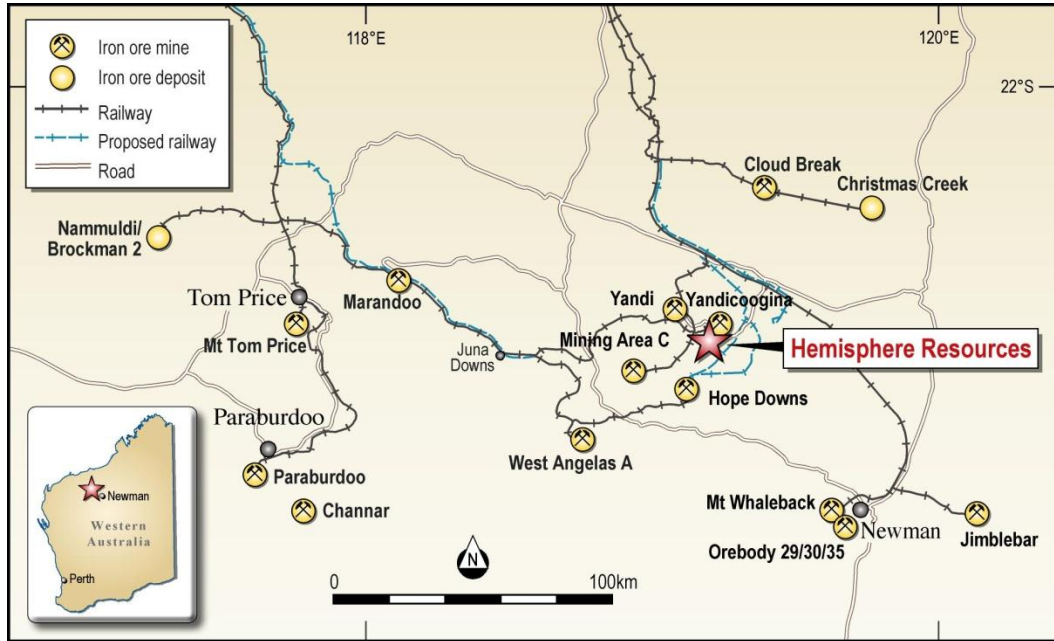


Figure 1: Location of Tenement EL47/1904.

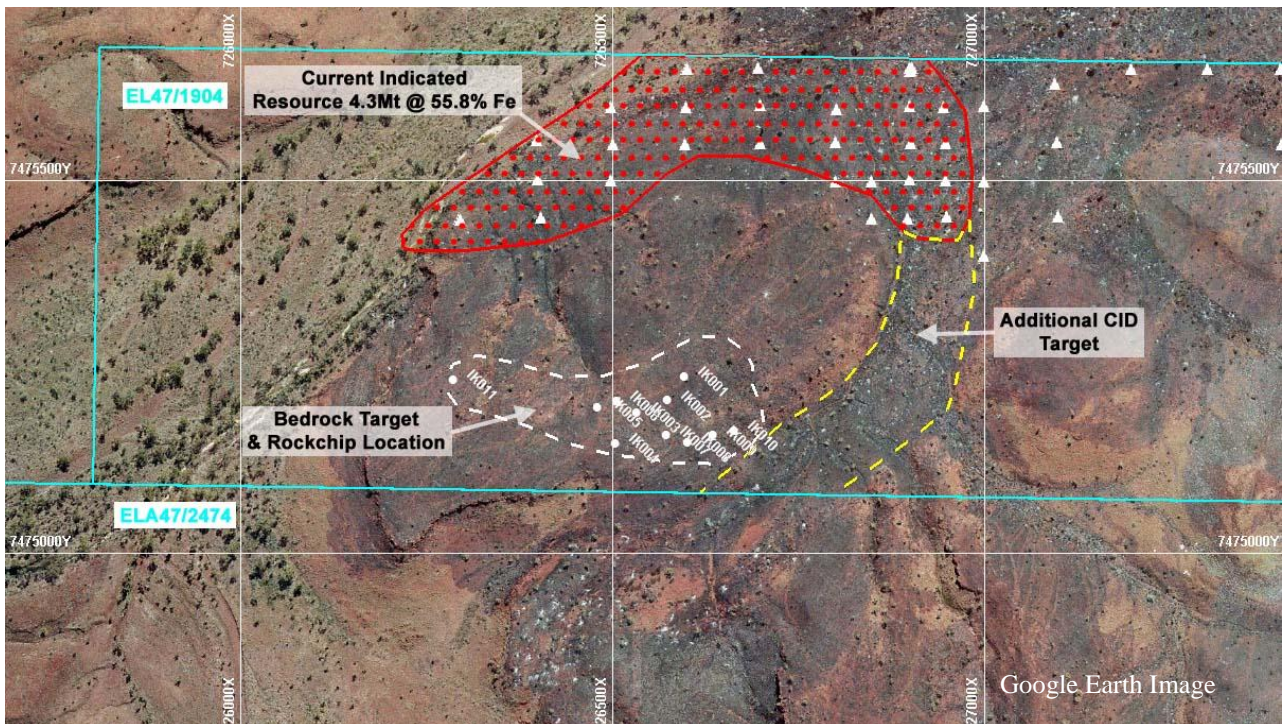


Figure 2: Location of Bedrock Samples with respect to currently reported CID Indicated Resource and additional CID target area.
